Request by the Georgia Department of Natural Resources to approve the conveyance of approximately 1,080 acres of tidally influenced land, a portion of Abercorn Island, to the Georgia Department of Transportation or to the United States of America or to an agency of the United States of America for the consideration of \$432,000. Request by the Department of Natural Resources to acquire from the St. Simons Land Trust interests in real property located in Glynn County to include a conservation easement on approximately 90 acres for the consideration of \$1,000,000 and the fee simple interest in 698 acres of marsh located for the consideration of \$10.
